Change of Ownership: Frequently Asked Questions

How can I ensure that I am the registered owner for my pet?

You can confirm that you are the registered owner by visiting your BC Pet Registry account online at bepetregistry.ca.

What documentation do I need to submit along with my Ownership Transfer form?

If the previous owner signs the Ownership Transfer form, no additional documentation is necessary.

If the previous owner signature is not on the transfer form, then the new owner will need to provide BC Pet Registry with one of the following documents as proof of ownership:

- Bill of sale from the previous owner to the new owner that includes the microchip number of the pet
- A letter from a licensed veterinarian (on their letterhead) indicating the microchip number and new owner of the pet.
- > A municipal licence that shows vaccination records including the microchip number of the pet
- Adoption agreement for the pet in the new owner's name
- > Previous owner's death certificate or obituary notice if the previous owner is deceased

Is there a cost to transferring ownership?

No, there is no cost.

How long does it take to process my change of ownership form?

Ownership transfers are processed in the order in which they are received. Processing time is up to 14 business days after all documentation is received.

What happens if I forget to submit documentation as part of my transfer request?

Your application will not be processed until all documentation has been received.

I have another pet I would like to register with the BC Pet Registry. How can I do that?

If your pet has a microchip, tattoo, or license, you can register them online at bepetregistry.ca.
