ACTIVITIES:

During the last year, the Cariboo and North Regional Council has provided feedback on various BC SPCA documents and has had discussions about how we can make our northern region a better place to live for both animals and people.

The Cariboo and North Regional Council met on a regular and scheduled basis throughout the year and held three (3) official meetings with the following highlights:

- July 12, 2023 Review of primer on the role of the Regional Council; Review of Regional Council survey results and discussion of strengths and weaknesses of Regional Council structure;
- November 15, 2023 Presentation of Emergency Response; Presentation of Draft BC SPCA Proposed Long-Term Vision;
 Presentation of Envisioned Priorities of the North; and
- February 28, 2024 Presentation of Draft Strategic Plan; Review of Draft revised Terms of Reference for Regional Councils; Item for Information: BC SPCA Community Animal Spay/Neuter Grant BC SPCA is prioritizing Northern BC for their 2024 granting cycle.
