#### ACTIVITIES:

During the last year, the Cariboo and North Regional Council has provided feedback on various BC SPCA documents and has had discussions about how we can make our northern region a better place to live for both animals and people.

# **ACTIVITIES** (continued from previous page):

The Cariboo and North Regional Council met on a regular and scheduled basis throughout the year and held two (2) official meetings with the following highlights:

- May 15, 2024 Presentation by Chair of importance of education and outreach within the region; proposal from RC for social media campaign; inquired about status of Northern Initiatives Group (received their report after the meeting); Continuing education/staff presentations suggestions; questions of strategic plan
- March 5, 2025 Update on plan for physical presence of BC SPCA in the North Cariboo region; update on Strategic plan

The Council members met on a regular basis throughout the year in nine working group meetings:

- April 25, May 21 & 28, 2024 to discuss the importance of education and outreach within the region;
- June 4, 2024 to clarify roles of Regional Council and issues of our region with Board Director;
- August 27, 2024 to review the Revised Regional Council Chair and Vice-Chair Terms of References (provided a feedback document on September 1, 2024);
- September 30, 2024 to discuss the September 23, 2024 meeting (please see below) with BC SPCA Board and Staff;
- October 24, 2024 to review Bylaw Amendments (provided a feedback document on November 4, 2024); and
- November 12, 2024 to review the Revised Regional Council Terms of Reference (provided a feedback document on November 29, 2024)

Two other meetings took part:

- September 23, 2024 meeting arranged by the BC SPCA Board and Staff and the Cariboo and North Regional Council to clarify the roles of the Regional Councils, discuss support of the northern & Chilcotin regions, and how to enhance communication and engagement; and
- January 6, 2025 meeting arranged by Christy King, BC SPCA to discuss gaps and needs assessment of our region given the closure of the BC SPCA North Cariboo Branch

There were three Regional Council Continuing Education Webinars attended by our members including:

- Farm animal welfare advisory council (FAWAC) with Marcie Moriarty on August 21, 2024; and
- Animal transfer program with Rachel Weist on February 19, 2025

In addition to the official meetings and continuing education webinars, a presentation of the Long-term Vision & Strategic Plan 2025-2030 was held on June 12, 2024.

Since the last AGM in March 2024, our Regional Council convened three (3) times:

- Virtually on June 5, 2024,
- Virtually on October 24, 2024, and
- In-person (hybrid meeting with some attending virtually) on March 1, 2025, at the BC SPCA Kelowna Community Animal Centre.

## ACTIVITIES: continued from previous page

The Region met two (2) times for working group meetings:

- Virtually on October 24, 2024, following the Regional Council meeting, to discuss and review proposed bylaw amendments and provide feedback to the Board of Directors, and
- Virtually on November 19, 2024, to discuss and review proposed changes to the Regional Council Terms of Reference and provide feedback to the Governance Committee and the Board of Directors.

The Chair and Vice-Chair both undertook between meetings to organize working group meetings, prepare Agendas, communicate with Regional Council members, collate responses, and complete feedback forms.

By conducting working group meetings and soliciting feedback via email, the Regional Council reviewed and provided feedback on the revised Regional Council Terms of Reference, the revised Terms of Reference for the Regional Council Chair, the revised Terms of Reference for the Regional Council Vice-Chair, and the proposed Bylaw amendment package.

The opportunities to provide feedback on the three Terms of Reference, reflecting the evolving role of Regional Councils, and the proposed Bylaw amendments were appreciated by the Regional Council, and these opportunities enhanced the engagement of Regional Council members in their roles and responsibilities.

At the March 1, 2025, meeting, we received a presentation on the Strategic Plan for the Society and Regional Council members were given an opportunity to ask questions. We also scheduled dates for the Regional Council's upcoming meetings in the 2025/2026 governance year.

There were two (2) Regional Council Continuing Education Webinars attended by our members including:

- Farm Animal Welfare Advisory Council with Marcie Moriarty on August 21, 2024, and
- Animal Transfer Program with Rachell Weist on February 19, 2025.

# **BUDGET CONSIDERATIONS:**

- Serve as the conduit through which a Member or a group of Members within a region can bring forward animal welfare or governance related issues for consideration by the Council, and if considered appropriate, make written recommendations, along with any proposed resolutions, to the Board for consideration with respect to those items.
- Consistent with these Terms of Reference, establish one (1) or more informal working groups to further the work of the Council, on the understanding that such activities are consistent with these Terms of Reference, do not require staff representation, and reported upon at the next meeting of the Council.

- Receive and review a report at each meeting from the Regional Directors on the recent activities of the Board.
- Provide advice and input to the Governance Committee on the Constitution and Bylaws of the Society on a biennial basis or more often as required by the Committee.
- Provide input and recommendations in the development of the Society's strategic plans.
- Attend educational sessions on Society programs from time to time to be actively informed on the work of the Society and lend support to such programs as necessary []]
- Provide advice and input on the development and regional implications, if any, of Society animal welfare position statements.
- Identify and recommend candidates for election or appointment to the Board consistent with the skills and attributes identified by the Board.
- Undertake an annual evaluation of the Council's performance, with the support of staff.
- Prepare a written report that includes a list of Council members and outlines the Council's annual activities for the membership at the Society's Annual General Meeting.
- Undertake other duties as required by the Board

# ACTIVITIES:

The Vancouver Island, Gulf Islands and Powell River Regional Council had the opportunity to participate and provide feedback on Regional Council Terms of Reference and proposed amendments to the Society's bylaws. Two (2) continuing education sessions were also held during the term to expand understanding and knowledge of BC SPCA programs.

The Regional Council convened two (2) scheduled formal meetings this year:

- May 29, 2024
- In-person meeting on February 8, 2025, held at the Victoria Community Animal Centre.

Craig Daniell, Chief Executive Officer of the BC PSCA, attended the in-person meeting to present and discuss the approved strategic plan.

A working group meeting was held on August 20, 2024 to review and provide feedback on the Regional Council Terms of Reference. Members also provided comprehensive feedback on proposed amendments to the Society's bylaws. The opportunity to provide feedback on the Terms of Reference and Bylaws was appreciated and enhanced engagement of Regional Council members in their roles and responsibilities.
