3. The **BC SPCA** reserves the right to withdraw the use of its name and logo at any time and requests by the BC SPCA to the Fundraising organization to remove logos must be honoured within 1 business day.
4. The **BC SPCA** shall incur NO COST OR LIABILITY associated with the program.
5. The **FUNDRAISING ORGANIZATION** acknowledges that due to limited resources, the BC SPCA cannot guarantee promotion of corporate fundraising initiatives.
6. The **BC SPCA** is unable to provide endorsements for non-BC SPCA products and services.
7. The **FUNDRAISING ORGANIZATION** will not have access to BC SPCA donor or contact lists.
8. The **FUNDRAISING ORGANIZATION** agrees to handle any monetary transactions and to present the proceeds to the BC SPCA within **30 days** following the conclusion of the program, or agreed upon date. For ongoing programs, funds are to be submitted quarterly unless otherwise agreed upon with your BC SPCA representative.
9. The **FUNDRAISING ORGANIZATION** agrees to act with fairness, integrity and in accordance with the law.
10. The **FUNDRAISING ORGANIZATION** agrees to keep donor/customer information confidential.
11. The **FUNDRAISING ORGANIZATION** agrees to make it clear what percentage or amount of the fundraising initiative goes to the BC SPCA.
12. The **FUNDRAISING ORGANIZATION** agrees to disclose immediately to the BC SPCA any actual or apparent conflicts of interest or loyalty.
